## More Detail.

### 1. Management.

The XXX Synagogue Board/Council has in turn approved an “Environmental Impact Team” in accordance with EcoJudaism guidance to investigate and improve on issues highlighted in the EcoJudaism Audit. (See “Getting Started”–Environmental Impact Team & 5 E’s” from EcoJudaism.) The Environmental Impact Team represents different generations of our Community or/and people with different lifestyles. On the date of approval of this policy, the Environmental Impact Team is currently as follows:

### 2. Prayer.

XXX Synagogue promotes environmental activities as an expression of our concerns for the environment with follow up actions and frequently delivers special sermons about environmental issues while highlighting our current environmental projects (such as the Environmental Impact Team and EcoJudaism) and actively encourages the congregation to become involved through follow-up actions. The environment is a constant theme throughout the Jewish year and Rabbis include the environment as an important theme in many aspects of synagogue engagement.

### 3. Teaching.

The environment features throughout the year as a teaching theme in our education syllabus for those under Bar and Bat Mitzvah age, in our Bar & Bat Mitzvah teaching, our youth and adult programming, in our synagogue’s shiurim and during Jewish and world environmental touch point events. Wherever possible, learning materials, texts and prayers are provided online to reduce energy consumption.

## 4. Community.

XXX Synagogue is committed to engaging with our community regarding environmental issues. EcoJudaism events and values are actively promoted, specific environmental issues are given particular focus such as waste and the connection to the mitzvah Bal Tashchit, not to destroy or to waste, and on repairing and improving the world through the Jewish concept of Tikkun Olam. Our synagogue organises events around Jewish festivals (Sukkot, Tu B'Shevat) that bring awareness to environmental issues and invites local leaders, environmentalists, organisations, providing opportunities for members to address local and national environmental issues.

## 5. Communications.

XXX Synagogue's communications (eNews, website, Social Media and other) focus on environmental issues, provide updates on the progress of our environmental projects and encourage members to become involved. Specifically, our communications highlight environmental issues that are relevant to current parashot, Jewish holidays and environmental touch-point events within in the Jewish community, nationally and globally, and as a reflection of the connection between Judaism and the environment. These communications provide additional relevant information about solutions to environmental issues for members at home, at work, in the garden, within the Jewish community, and nationally and globally. The communications include a call to action and encourage members to become involved, to support campaigns, to become a volunteer for the Environmental Impact Team, and provides an opportunity for members to share their concerns on environmental issues, and to give feedback. Our communications offer practical lifestyle tips and advice on caring for the environment. Specific actions and awareness of certain issues are shared including encouraging members to consider alternatives highlighted in the EcoJudaism Audit Lifestyle Section. Additionally, public transport, walking and cycling advice is included for our events at the Synagogue. At the end of the Jewish year, a digital member survey will be distributed to our members to receive feedback about changes they have made to their lifestyle. Feedback and approach to communications will be reviewed and improved upon for the following Jewish year through a digital member survey.

Rabbis embolden our communications by highlighting them during services, classes and meetings current to the date of release, sometimes with follow up actions and actively encourage members to get involved.

## 6. Land, Buildings & Consumables.

XXX Synagogue has made several changes to our synagogue's building and consumables with consideration to the environment. Over time, our Environmental Impact Team will review ways in which to improve on this further and put forward for consideration and approval by the XXX Synagogue Board/Council. The following are current measures taken by XXX Synagogue:

- Composting facilities are available on our synagogue premises.
- A space on the roof is reserved for planting with students and members and the space can be used most times for members to connect with nature and become involved in planting.
- In terms of energy efficiency, the boilers on our synagogue premises have a low environmental impact ( $\text{NO}_x < 40\text{mg/kWh}$ ) for maximum BREEAM credits.
- The lighting in our synagogue building uses energy-efficient light bulbs in our main sanctuary, in some of our halls and in some of our offices and classrooms. For each light fixture that needs replaced, an LED fixture is installed.
- The water supply to our synagogue premises is metered.
- Some of the toilet cisterns on our synagogue premises are fitted with water saving devices.
- In the event of the need to undertake a building/refurbishment project, our synagogue would insist that it be subject to a BREEAM or similar assessment to ensure best practice in sustainable building design, construction, and operation.
- The basement serves as a bicycle storage space for members who cycle.
- Our synagogue generates some of energy we use from solar PV panels.
- Our community administration uses recycled paper.
- Paper usage is reduced through double-sided copying/printing and digital distribution.
- Disposable catering products (e.g., paper cups and plates etc.) provided by our community administration are biodegradable and we will move to having no disposables and all cleaning products provided by our community administration are environmentally friendly.
- Recycled toilet paper is provided by our community administration.
- Paper, glass, cans, plastics, fabrics, TerraCycle or similar are collected, sorted and recycled by XXX Council.
- Only vegetarian or vegan food is permitted within the building at all times included catered events.
- On some occasions our synagogue invests its funds ethically and rates the ESG
- Users of our premises are encouraged to minimise resource use.
- Our carbon emissions will be calculated and offset through communal tree-planting.
- We have set targets to reducing our carbon footprint

**For rented space in our Synagogue:**

Our tenants have a direct communication with our Synagogue on environmental actions. They are included in our carbon footprint calculation, and our tenants help set targets to reduce emissions from their space and processes. Our tenants use only vegan/vegetarian options for catering. Our tenants operate a no-paper policy and keep all work digital. We provide our tenants with updates such as annual waste usage reports. Sometimes we collaborate with our tenants on environmental activities such as planting seeds together for growing on the premises.
